

**CURRENT DANMAR LINES LOW SULPHUR SURCHARGES**

The surcharge will be applied for all shipments that have a Bill of Lading date of January 1st 2015 or later. The actual surcharge amount is dependent on the trade lane. DHL has calculated an average surcharge based on what our carriers impose.
